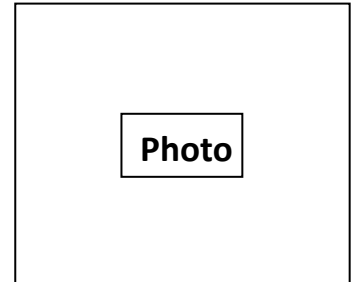

## **ABOUT THE COURSE:**

- The courses are separated into two levels: **A Beginner**  
**B Experienced Farrier**
- The farriery course consists of two modules. Each module is for three weeks, and the dates are announced every year.
- To get the certification as a Qualified Farrier, a student has to attend the 2 modules in one year.
- Certificate of Participation will be given at the end of the 2 modules. A special exam will be organized after a minimum of 2 years of experience working full-time as a farrier in India. After these exams, according to the result, you will receive a Certificate of Graduation as an “FAF India Qualified Farrier”
